# Terms and Conditions of LGCA Membership

#### Introduction

- 3. **Junior Members**: A member who is under 18. Please note if you are under 18, you need the consent of a parent/guardian to register. Please contact us directly to register someone under 13 as an LGCA member.
- 4. **Affiliate Members:** Our partners and stakeholders who work in or have an interest in Lyde Green.
- 5. Statutory Authority Members: Local statutory authority bodies whose areas cover Lyde Green.

### Membership Benefits include:

- News receive regular updates on local news and activities.
- Events come together at local community events by LGCA.
- <u>Voting Rights</u> attend our General Meetings and vote to elect LGCA trustees (only over 18s can vote)
- Quality of Life take pride in your community and strive to improve the area for yourself and neighbours.
- <u>Community Centre</u> get information about our Community Centre first.
- <u>Opportunities</u> be welcome to get involved with the LGCA, including volunteering, activities and events.
- Representation have your say about the future of Lyde Green and be represented by LGCA who ensure the best interests of the community are presented to relevant people.
- <u>Local Partners</u> live in a great place where partners work together to get the best for our community through the Lyde Green Partnerships group.

#### By requesting to become a member, I understand:

- Attendance at any meeting or event is by personal choice, I'm under no obligation to LGCA whatsoever and can if I wish just receive or submit information, comments or ideas.
- I can opt out of receiving contact from LGCA at any time.
- I will receive contact from LGCA by email, unless I request otherwise.
- My personal details will not be distributed outside of LGCA at any time without written
  permission but other information I provide, such as answers to surveys, may be used
  anonymously by LGCA and shared with other bodies for the development of the community.
